SECTION 6 - ACCIDENTAL RELEASE MEASURES

SECTION 10 - STABILITY AND REACTIVITY

<u>REACTIVITY</u>: No significant decomposition products. This cosmetic product is stable under normal conditions of use, but, if exposed to extreme temperatures (above 50°C) for prolonged periods, may change texture and colour.

<u>CONDITIONS TO AVOID:</u> Keep containers tightly closed. Containers should be kept dry.

INCOMPATIBLE MATERIALS: Strong oxidising agents.
